TERMS OF SERVICE

In these terms, the "Subscriber" is referred to the customer who purchases Range Internet services. SUBSCRIBER is responsible for payment of all charges that will appear on its monthly bill from Range. Failure to pay these charges may result in termination of service for non-payment. Initial bill will include prorated charges on a daily basis from the date service begins until first full monthly billing cycle, PLUS one full month in advance.

SUBSCRIBER must pay Range a modem/router lease fee of \$10, unless customer is upgrading or subscribing to Data Only Advanced, Premium, or Gigabit broadband 2.0 packages or Voice/Data Standard broadband or higher. Those packages include the modem/router lease without the additional \$10/month fee. The modem/router lease covers damage inherent to defect of equipment, damage due to lightning or power surge, accidental damage caused by SUBSCRIBER.

If SUBSCRIBER disconnects broadband service, SUBSCRIBER must return modem/router to RANGE within two weeks of disconnect date, or SUBSCRIBER will be assessed a Router Fee of \$300 for the Gigaspire Max U12 and \$150 for the Gigaspire U6.1 lineup. SUBSCRIBERS that are on packages that do not have a Next Generation Router, will not be required to return their router. SUBSCRIBER must maintain service for six months.

SUBSCRIBER selecting a broadband term discount and/or feature bundle will continue to receive discount as long as SUBSCRIBER is in this Agreement. Pricing for broadband and/or features will go to full pricing if Agreement expires and a new Agreement is not signed.

SUBSCRIBER selecting a Promotional Offer hereby agrees to the terms and conditions as may be defined by RANGE in the applicable promotional literature (attach). SUBSCRIBER selecting a term discount for a 1-, 2-, or 3-year term will be subject to an Early Termination Fee.
