



#### The Great Pumpkin Hunt Rules:

1. The Great Pumpkin Hunt sponsored by Range will be advertised on Northern Wyoming Daily News, KZMQ, KKLX, KVGL, KWOR, Thermopolis Independent Record, KDNO, Dubois Frontier, Dubois Roundup, KTAK, Newsletter Journal, KASL, The Sundance Times, KZZI, Independent Press, KIKC, and Facebook beginning on October 2, 2024. A new clue will be announced each day on various morning shows in each area and on the respective location Facebook Event page from Monday, October 21 through Friday, Oct. 25, 2024. The clues will be announced on morning shows each day from 6-9am and will be posted on the respective location Facebook Event page at 6am each day. Clues can also be found on Facebook by searching the respective location hashtag - #forsythpumpkin, #worlandpumpkin, #duboispumpkin, #thermopolispumpkin, #newcastlepumpkin, #sundancepumpkin.
2. Must be 18 years or older to win.
3. The finder of the Range Great Pumpkin must immediately return it to the Range office in the town where the Pumpkin Hunt is being held during hours of operation (Monday-Friday 8am – 5pm) to qualify for the Grand Prize Package.
